They should identify common themes, concerns, and suggestions. From there, they can develop a clear action plan outlining steps to address the issues raised.

As leaders, we must meet each child where they are, guiding them to their highest potential. Embracing equity is crucial to fulfilling our mission for all families.

7. What do you think the R7 District does well and what do you think they could improve on?

Listing all the positive aspects would take up too much space, but it's worth highlighting that R7 has exceptional teachers and staff. Our focus on students and academic achievement is unwavering, and we're making significant strides in real-world learning and trade opportunities. As these needs are not being met, it leads to children that are unable to learn in school. I have a passion to see children succeed and receive a high quality education without falling through the cracks. As a social worker, a big part of my job is to listen and be present while building bridges with people to create success.

I have a daughter that is a teacher in this district and see her giving so much to this system and still feeling like it's not enough. I want to decrease educational disparities by increasing educational specialists such as reading and math specialists to meet the needs of struggling students and to help already overburdened teachers. The beautiful thing about public education is that we can all come together to share ideas and create solutions to prepare students for an increasingly diverse and global world.

2. If elected what would be your top three priorities during your term?

Increase comprehensive in- school resources to address the national mental health crisis facing kids.

Continuing to provide high quality education to all students regardless of their circumstances.

To decrease educational disparities within the school district.

3. What do you see as your primary job as a school board member?

Work as part of a team to create policy for the district, manage and maintain the budget for the district, advocate for all students in the school district at the local and state level, and evaluate the Superintendent. Actively engage with the community and be transparent in our decisions.

4. What three qualities do you have that you think will allow you to be a successful school board member?

I have lived in this community for over 20 years and I have 4 children that went through and successfully graduated from LSR7. As a social worker I have the skills to listen and communicate to build a shared community. I have worked in a neighboring school district and I have an understanding of how complex schools are, and I understand the struggles to meet the needs of the most vulnerable students while remaining a district with distinction.

5. How will you as a school board member connect, engage and communicate with the community?

Attending events at the schools, meeting with students at their clubs, Townhalls, emails, social media, phone calls.

6. Although standardized test scores show increasing improvement in our schools, significant differences among economic and cultural groups still exist. What can the District do to continue the overall success in academic achievement while significantly closing the achievement gap?

The district can use the Title 1 funds that are given to the most at risk schools within the school district in a fiscally responsible way. We know that the children that attend Title 1 schools are the children that are most at risk that is why those schools are given those funds by the government.. Those funds should be used as intended to provide resources to those schools not split between several schools. Meeting those children's needs in a responsible way will aid in closing the achievement gap.

Academics. We are a very academically sound school district. We have regularly proven that students receive a high quality education that ultimately prepares them for the world.

Educators. We have dedicated principals, teachers, and support staff. They strive to help all students be seen and feel cared for daily. Our educators have proven they are dedicated to the children in this district during these challenging times to be a teacher.
